

## THE GREAT TUMBLR BOOK SEARCH CONTEST

### OFFICIAL RULES

#### NO PURCHASE NECESSARY

**DESCRIPTION OF THE CONTEST:** The Great Tumblr Book Search Contest (“Contest”) is designed to give Entrants (“Entrants”) the opportunity to submit an art, food and drink, or humor book idea explained to be considered for publication with Chronicle Books. The book idea must be explained via Tumblr.com. The Prizes will be awarded to the Entrants who receive the highest score from the judges in accordance with these Official Rules. All federal, state and local laws and regulations apply. Entrants agree to be bound by the terms of these official rules and by the decisions of Chronicle Books LLC (“Chronicle”), which are final and binding on all matters pertaining to this Contest.

**ELIGIBILITY:** This Contest is open only to legal residents of the fifty United States and the District of Columbia who have reached the age of majority in their state of residence. Void where prohibited by law. The following individuals are not eligible: (a) employees of Chronicle Books or Tumblr and their parent, affiliate and subsidiary companies; and (b) members of the immediate family of a person in (a) and/or those living in the same household as a person in (a).

**HOW TO ENTER:** This Contest begins on 2/2/2015 12:01 am EST and ends on 3/2/2015 at 11:59 pm EST (“Contest Period”). To enter, go to <http://cbks.co/IndHt> (the “Site”) and follow the onscreen instructions. Entrants will be invited to submit the URL of their Tumblr submission post and basic contact info. (“Submission”). Submissions must be submitted during the Contest Period and contain the minimum information listed on the contest entry page. Chronicle’s clock is the official clock for the Contest. Submissions using macro, script or other forms of automatic entry will be disqualified. Chronicle or its designated representatives reserve the right to disqualify any Submission that does not conform to these Official Rules as determined by Chronicle in its sole discretion. Chronicle will not notify Entrant whether the Submission has been disqualified. Limit one Submission per person per email address during the Contest Period.

**SUBMISSION REQUIREMENTS:** Each Submission must include the URL of the Tumblr submission post. Each Submission post must also comply with the following:

Each Tumblr submission post must be tagged “Tumblr Book Search” and include:

The working title of the art, food and drink, or humor book

A short written synopsis of the art, food and drink, or humor book idea (200 words or less)

Examples of the book’s concept (can be photos, animated gifs, artwork, video, text, or any media supported by Tumblr)

Entrants are only required to submit one Tumblr post to be considered by the judges but are also encouraged to submit more posts to further explain and expand upon their book idea. Each additional post to be considered should be tagged “Tumblr Book Search.”

The Submission must be your own original work, created solely by you; must not have been previously published, released or distributed in any form; must not have won any award; and must not infringe the copyright, trademark, privacy, publicity, or other personal or proprietary rights of any person or entity.

The Submission must not contain or reference any names, products or services of any company or entity or any third party trademarks, logos, trade dress or promotion of any brand, product or service.

If any persons appear or are referred to in the Submission, you are solely responsible for obtaining, prior to submitting the Submission, any and all releases and consents necessary to permit the exhibition and use of the Submission by Chronicle in accordance with these Official Rules. If any person appearing in any Submission is under the age of majority in their state of residence, the signature of a parent or legal guardian is required on each release.

Submissions that are lewd, obscene, sexually explicit, pornographic, disparaging, defamatory, libelous, or Submissions that otherwise contain inappropriate content or objectionable material may not be submitted and may be disqualified at any time in Chronicle’s sole and unfettered discretion.

The Submission must not contain any personally identifiable information of any person other than yourself. Should you include personally identifiable information about yourself in your Submission, you acknowledge and agree that such information will be disclosed publicly and you are solely responsible for any consequences thereof.

Chronicle reserves the right in its sole and unfettered discretion to disqualify any Submission that it believes violates or potentially violates any of the foregoing requirements or otherwise fails to comply with any provision of these Official Rules. The decisions of Chronicle on this and all matters pertaining to the Contest shall be final and binding.

Entrants agree to indemnify and hold Chronicle harmless from and against any suits, claims, losses, damages and expenses, including reasonable attorney fees, that it may sustain from any breach of a representation or warranty made by the Entrant or the use of any rights granted by the Entrant to Chronicle hereunder.

judging: All entries will be judged by editors at Chronicle Books and Tumblr, based on the following criteria: Professionalism and clarity (25%); Originality (25%); Use of Tumblr as a medium to express your book idea (25%); and Alignment with editorial priorities (25%). In the event of a tie, the person among the tied entries with the highest score in will win. Decisions of judges are final and binding. Winner will be notified by telephone and/or email. If Chronicle cannot locate a potential winner within 7 days of attempted notification, the prize may be forfeited and an alternate winner may be selected.

Prizes and APPROXIMATE RETAIL VALUE:

There will be [6] prizes awarded (“Prizes”), each consisting of the following:

3 Grand Prizes: One grand-prize winner in each category of art, food and drink, and humor will receive: 1) A \$300 gift card to ChronicleBooks.com. 2) 30-minute phone consultation with a Chronicle Books editor

about the submitted book idea. 3) Tumblr and book idea featured on Chronicle Books Tumblr. Approximate retail value of prize is \$300.

Three Runners-Up: Three runners-up will each receive: 1) A \$100 gift card to ChronicleBooks.com. 2) Tumblr featured on Chronicle Books. Approximate retail value of each prize is \$100.

All other expenses not specified herein are the responsibility of the winner. ALL TAXES ARE THE SOLE RESPONSIBILITY OF THE WINNER.

ALL PRIZE CONDITIONS: Additionally the art, food and drink, or humor book idea submitted by the grand-prize winner will be considered for publication by Chronicle Books. The grand-prize winner retains all rights to the book idea and Chronicle Books will not use the submitted idea or materials for any purposes except to consider them for publication. Chronicle Books does not guarantee publication of the book idea submitted by the grand-prize winner. The idea will only be considered for publication. If Chronicle Books is interested in the idea, it will contact the grand-prize winner directly to discuss and will not take any action on its own. The grand-prize winner is in no way legally bound or required to publish his or her book idea with Chronicle Books.

Specifics of prize will be determined by Chronicle in its sole discretion. No substitution or transfer of a prize will be permitted, except that Chronicle reserves the right to substitute a prize of equal or greater value if the advertised prize is unavailable. Prize cannot be transferred by winner or redeemed for cash and is valid only for the items detailed above, with no substitution of prize by winner.
